# Introduction to THLN

- First statewide 501c4 for animals in the country
- 45 year old organization
- Our mission is to promote the humane treatment of animals through legislation, education and advocacy
- Operated solely by volunteers for 35 years
- Chapters throughout the state

## **Why Legislation Matters**





- Loco was a 8 month-old pup stolen from his family's backyard, found days later missing both eyes.
- Texas law at the time provided only misdemeanor charges with minor consequences.
- Loco put a face to the weak animal cruelty laws that existed in Texas at that time.
- Animal abusers are now subject to state felony charges, up to 2 years imprisonment, and can face up to a \$10,000 fine.

### Why should animal cruelty be taken seriously...



- Identifies people engaging in other crimes.
- Exposes family violence.
- Indicator that children at risk to themselves and to others.
- Witnesses or victims more comfortable talking about it.

## **THLN Victories** – **Animal Friendly License Plate**

#### **ANIMAL FRIENDLY LICENSE PLATES**



In 1997, THLN passed H.B. 3250, which created an "animalfriendly" fund for the state through the sale of specialty license plates. We continually monitor this fund each legislative session to ensure that the money continues to be used for it's intended purpose.

## **THLN Victories Con't**

### DOG FIGHTING ACT

THLN played a major role in passing this landmark act which outlawed dog fighting in Texas.

#### DFA INITIALLY PASSED

Outlaws dog fighting, promoting a dog fight, training dogs to fight, and attending a dog fight.

#### DFA AMENDMENT HB 916 PASSED

The Dog Fighting Penalty Enhancement Bill increased the punishment for dog fighting from a misdemeanor to a state jail felony. and increased the punishment for attending a dog fighting exhibition.

#### DFA AMENDMENT SB 554 PASSED

The Dog Fighting Classified as Organized Crime Bill allows dog fighting to be classified as organized orime and additionally allows for all property associated with dog fighting to be forfeited.



### **CANINE ENCOUNTER LAW**



THLN passed a law in 2015 requiring a one-time training course for law enforcement officers to prepare them for a safe, non-confrontational outcome when encountering a dog. As a result of the Canine Encounter Law being passed, the number of dogs who have been reported shot by police has drastically lowered.

## The Texas Legislature

- Convenes every other year in odd numbered years (2019, 2021, 2023)
- 140 days in duration (20 weeks) in reality, only 95+/- "workdays"
  - Governor has 20 days post-sine die to approve/veto bill
  - Special sessions

*2021 House*: 83 Rs and 67 Ds (150) *2021 Senate*: 18 Rs and 13 Ds (31)

## How a Bill Becomes Law in Texas

#### How a **bill** becomes a **law** in Texas The Texas Legislature could pass as many as 1,000 new laws this session, with lawmakers working their way through a system designed to kill bills, not pass them. ## **The Texas Legislature in 2023**

- 5 Senators + 25 House Members Retired = At least 30 new members
- January 10, 2023, First day of Regular Session
- May 29, 2023, Last day of Regular Session
  Governor has 20 days post-sine die to approve/veto bill
- 6927 bills filed in 2021-
  - > 1,181 passed to the Gov's Desk







### Animal Issues are Bi-Partisan

#### February 16, 2017:

Congressmen Roger Williams (R-Austin) and Marc Veasey (D-Fort Worth) introduced a bipartisan resolution to designate April 11th as 'National Pet Adoption Day' and the month of April as 'National Pet Adoption Month' to encourage pet adoption from local animal shelters and rescues.



## The Texas Licensed Breeders' Program





## The Sunset Bill does not include the <u>Texas Licensed Breeder Program</u>

- The Texas Licensed Breeder Program was not included in the Sunset Bill that passed (HB 1560)
- Over 500 comments in 2020 asking to save the program
- More breeders need to come under the Program



## Safe Outdoor Dogs Act (SB 474/HB 873)



- 91 co-authors and sponsors
- 2 other bills brought
- Brought in 2015, 2017, 2019
- Defines adequate shelter
- Removes chains as a method of restraint
- Removes 24-hour warning so tickets are allowed at the scene
- Grants for cable tie outs

## Safe Outdoor Dogs Act (SB 474/HB 873)

#### <u>SB 474</u>

- Introduced in January
- Referred to Criminal Justice Committee
- Reported favorably by committee in April
- Placed on intent calendar in April
- Passed Senate in April
- Sent to House
- Referred to Criminal Jurisprudence Committee
- Reported favorably in May
- Passed House after third reading in May
- Governor's desk in May

#### <u>HB 873</u>

- Filed in December
- Referred to Criminal Jurisprudence Committee in March
- Reported favorably in March
- Sent to Calendars in April
- Placed on House Calendar in May
- Passed House in May

### Safe Outdoor Dogs Act SAVED



The Safe Outdoor Dogs Act Goes Into Effect: A New Day For Texas Dogs



#### HB 1071



Allows specially trained dogs to accompany vulnerable witnesses in court. A dog's calming presence can help get vital testimony into the record so that justice can be served.

## HB 604 - Microchipping Bill



Sec. 823.004. MICROCHIP SCAN REQUIRED.

As soon as practicable after an animal is placed in the custody of an animal shelter or a releasing agency as defined by Section 828.001, <u>the shelter or agency shall</u> <u>scan the animal to determine</u> <u>whether a microchip is</u> <u>implanted in the animal.</u>

### <u>Removing Animals from Dangerous Situations</u> (Possession Ban)

Relating to conditions of community supervision for defendants convicted of certain criminal offenses involving animals.

If a judge grants community supervision to a defendant convicted of an offense, the judge may:

(1)Require the defendant to relinquish custody of any animals in the defendant 's possession;

(2)Prohibit the defendant from possessing or exercising control over any animals or residing in a household where animals are present; or

(3)Require the defendant to participate in a psychological counseling or other appropriate treatment program for a period to be determined by the court.

## Sales Taxes for Adoptable Dogs

#### SB 197 - 11/16/20 - Nelson District 12

 Relating to a sales and use tax exemption for animals adopted from or sold by nonprofit animal welfare organizations.





## 2023 Legislative Session: <u>Humane Curriculum</u>

- Overarching problem: The lack of formal education in Texas on how to treat and behave around animals has caused growing problems with dog bites, poor treatment of animals, and threatens the overall safety of Texans, especially children.
- <u>Solution</u>: Introducing a third-grade humane curriculum in Texas public schools would teach children how to properly interact with and treat animals to increase the safety and wellbeing of children, animals, and our families and communities.

## 2023 Legislative Session: Texas Licensed Breeder Program

- 2021: House Bill 1560 preserved the *Texas Licensed Breeder Law* which regulates large-scale commercial dog and cat breeders. The breeder law came under Sunset review in 2020 and was saved.
- The *Texas Licensed Breeder Law* was created in 2011, per the passage of HB 1451, in response to routine seizures of hundreds of cruelly treated animals from large-scale dog-breeding operations or "puppy mills".
- Proposed changes would include going from 11 to 5 breeding females and removing the proof of sales requirement.



## 2023 Legislative Session: Humane Pet Store Bill

- 2021: HB 1818 would have required retail pet stores to source the cats and dogs they sell from animal control agencies, shelters, and rescue groups in counties with populations over 200,000.
- Several Texas cities have already switched to this humane model, including Austin, El Paso, The Colony, Euless, San Antonio, and Waco.



## Safe Outdoor Dog Roll Out: January 19, 2022

- 1. Oct. 19-Jan. 19: search for resources and prepare roll out
- 2. Created one pagers, video, updated website, press release, and LTEs (c3 work)
- 3. Relied on our partners and stakeholders to help with outreach
- 4. Targeted outreach to LEOs, ACOs and Judges
- 5. Community Meetings





## Safe Outdoor Dog Roll Out: January 19, 2022

## <u> Big Cat Public Safety Act – HR 263</u>

- Federal legislation would stop "breed & dump" cycle.
- Big Cats in private ownership continues to threaten public safety and first responders.
- HR 263 passed the US House but has not yet passed the US Senate.
- Last day of Federal Session is December 21, 2022.
